EXPRESSION OF INTEREST FOR PROVIDING PREMISES FOR HOSTELS FOR INDIAN INSTITUTE OF PETROLEUM AND ENERGY (IIPE), VISAKHAPATNAM, AP ADVT NO. IIPE/EOI/001/2022-23

The Government of India under AP Reorganization Act 2014 has offered to set up several Central Funded Institutions of National importance in the State of Andhra Pradesh (AP), one of them being Petroleum University. Accordingly, under the aegis of Ministry of Petroleum and Natural Gas(MoPNG), a Petroleum University by the name 'IndianInstitute of Petroleum and Energy" (IIPE)' is set up. The Government of Andhra Pradesh has allotted 200 acres of land in Sabbavaram Mandal, Visakhapatnam for setting up IIPE. Till such time permanent campus is ready for occupation at Sabbavaram, the Institute is presently running at its temporary campus at Andhra University of College of Engineering, Visakhapatnam. Expression of Interest is invited for providing fully furnished premises for hostels of IIPE both for Girls' and Boys' to be effective for the academic year 2022 – 23 broadly as per the requirements given below. Basis EOI's received, IIPE will review the offers and commercial tender will be sent to the approved vendors. Basis, tender evaluation PO's will be placed.

- (1) The Hostel accommodation for 200 boys approximately and about 15 students shall be girls.
- (2) The vendor should provide catering also to the hostel students in the premises viz. Breakfast, lunch, evening snacks, dinner etc., as per the prescribed menu, for which a separate rate contract would be entered as per directives of IIPE, based on the previous year rates and present inflation and the vendor should have an experience of minimum two to three years in this field.
- (3) The accommodation shall be separate for Boys and Girls.
- (4) The premises shall preferably be within 10 Kms. radius from IIPE, Visakhapatnam $-530\,003$ premises, however if hostel facilities are available within short distance from the destiny will be given priority subject to the conditions satisfactory.
- (5) The premises shall preferably be at one place separately for Boys and Girls. However, for one reason or the other if the premises are not available at one place, there is an option that may be considered for premises at different places. EOIs may also be offered for the premises having less than said occupancy but can accommodate the maximum.

(6)ETRO The premises shall be under exclusive and dedicated usage of IIPE and no other guests are entertained.

- (7) The Agency shall have either full ownership of the premises and might have taken on long lease from third party. However, required proof of documentation to be submitted.
- (8) The lease agreement initially shall be for a period of one year; likely extendable by **One** more year basing on the efficiency and performance of the Vendor in terms of quality services to the students. The decision of the management of the institute is final in this regard.
- (9) The Agency shall provide the details of contact person who will be the single point coordinator and responsible for all the obligations.
- (10) A clause of termination of the contract with one month notice from IIPE side shall be incorporated in the agreement.
- (11) The bill shall be raised by the agency before 5th of every month for the previous month and payment shall be released within 10 days from the date of receipt of technically and commercially cleared bill after effecting necessary TDS and other statutory deductions.
- (12) Applicable GST shall also be paid subject to providing required documentation.
- (13) The agency to take required approvals, licenses if any for the premises to be used as Hostels.
- (14) The agency to allow continuous enjoyment of the licensed premises, amenities, furniture and fixtures thereof.
- (15) The agency shall give free access to the licensor and their representatives to enter into the premises at all times.
- (16) The agency to repair and keep in good working conditions, furniture, fittings, other equipment and drainage / sewage lines etc.
- (17) If at any time during tenure of the license, the premises are affected / destroyed / damaged on account of natural calamities, the agency to get them repaired / replaced immediately.

AMENITIES & FURNITURE:

KHAPA

- (18) Each room size should not be smaller than 10' x 12' (excluding the area of attached toilet) and shall accommodate two or three members as required.
- (19) Individual good quality, cot, bed, pillow, study table and chair shall be provided for each student.
- (20) All the rooms shall be equipped with Wash basin, mirror, cup boards, fan and tube lights as required.

- (21) All the rooms shall have attached toilet with hot water facility.
- (22) 24/7 uninterrupted water and power should be available to the rooms and the premises as required.
- (23) Power supply shall have suitable back up and it shall include Air conditioners load also.
- (24) All rooms must have a provision for Air conditioners which may be opted by the students.
- (25) A common television set shall be installed in a common hall with digital set top box connectivity.
- (26) Agency to provide additional space for common facilities like gym, indoor games (TT, Chess, Caroms etc.,) in each premises of the hostel.
- (27) Wi-Fi facility is to be provided free of cost to all the students.
- (28) Round the clock security 24/7 is to be deployed to the premises.
- (29) Surveillance CC Camera system is to be provided and maintained as required covering all the floors and important areas of the building.
- (30) Housekeeping and sanitation is to be maintained to the satisfactory levels.
- (31) Washing machine is to be provided at all floors.
- (32) Round the clock RO drinking and running water should be ensured.
- (33) Sufficient no. of chairs are to be arranged in the common recreation hall like for viewing television etc.
- (34) Daily newspapers of English, Telugu and Hindi are to be provided in the common recreation hall.
- (35) The vendor should take required licenses from the competent authorities like food license from FSSAletc.
- (36) The staff deployed at Girls' hostel shall be ladies only.
- (37) First Aid & Firefighting systems are to be in proper place.

The individuals/agencies financially sound and capable of meeting the requirements broadly as aforesaid but not limited to only those, may express their interest with their profile, building details, solvency details, experience, along with infrastructural plan and the time limit by which they can make the facility ready for occupation. The individuals/agency shall also to provide their IT returns of past three years.
